






Spell It Out!

Agency News Brief

- The train is picking up speed again as we head for a unit price system with capitated rates under Managed Care. OPWDD and CMS (Center for Medicaid Service) continue to make progress on NYS Waiver status. This means we, along with OPWDD, must prepare for the new funding and regulatory changes. To do so, we will enforce a daily billing model effective in July. We can no longer place people in workshops, so we will convert all of our other program types (ICF's, OPTS Programs, etc. to IRA's). We will deal with new Rate Rationalization methodologies for payments, and we will need to meet new regulatory changes, like Olmsted. New Horizons and our sister agencies have been preparing and working with OPWDD to effectively make these changes. These are profound changes which will reshape the service in our field moving forward.
- New Horizons announces the retirement of Board members Bruce Marley and Susan Hochhauser. We thank them for their many years of support and service and wish them the very best! We are pleased to welcome Beth Allen and Madelaine Watterson to the board.
- NHR reaches and agreement with SEIU negotiating team after months of deliberation. The new contract, if ratified on April 10th, will boast a bonus for all staff and a 1% salary increase which would become effective in September. This would be the first such increase in five years.
- Code of Ethics training continues to all Direct Support Professionals and some management staff. This
 innovative, meaningful and self-reflective training has now been completed by approximately 120 staff
 members.
- NHR continues to look to purchase another home to develop into a five person home for young adults aging out of residential school programs. We hope for this residence to open later in 2014.
- New Horizons receives an approved funding to increase the fire protection and safety at our Unionvale residence. The majority of the work will consist of replacing the old sprinkler system and creating fire breaks within the home.
- We say goodbye to Roger Loewer who passed away on March 1st. Roger previously lived at Amenia IRA and most recently resided at Unionvale IRA. He was a true character and was loved by many. He will be greatly missed. In addition, we say goodbye to a gentle woman and devoted mother, Mrs. Lee, who was the mother of John Lee, Jr., a Dwight Street IRA resident. She was also the wife of former Board member John Lee, Sr. and daughter of current Board member Helena Lee.






Congratulations to all of this year's team members who participated in the New Horizon's American Heart Walk Team. I personally thank them all for thinking about our community and the needs of others. Great job!


Positive Paws
